Following the Pledge of Allegiance, Councilman Bentz, Councilwoman Budd, Councilman Lynch, Councilwoman Mares, Councilman Montgomery, Councilman Polick, Councilwoman Steffey, and Mayor McCaffrey answered to roll call. Finance Director Haberstock, Solicitor McPeak Cromer, Chief Dziezgowski, Engineer and Acting Borough Manager Glister, Consulting Engineer Minsterman, and Public Works Director Volpe were also present. Borough Manager Stinner was absent.

10. Discussion to approve the monthly bills that have been paid

Mr. Montgomery asked on the CMA payment for Pennvest, what is that? Are we starting to pay the second Pennvest loan? Can somebody explain that to me?

Mr. Haberstock responded we have the payment to the CMA every month.

Mr. Montgomery stated we have had the \$77,000.00. But this is almost \$19,000.00 in addition to that.

Mr. Minsterman stated that is the current interest on the amount that they have spent to date. So, as CMA makes payments to their contractor, it is drawn from the Pennvest loan. Until the loan closes, you pay the interest on the outstanding principal. When the loan closes, then you will pay your debt service payment.

Mr. Montgomery asked would that be the interest and the principal?

Mr. Minsterman responded just the interest at this point.

- Mr. Montgomery stated I was under the impression we would not pay anything until the job was complete.
- Mr. Minsterman stated the Pennvest rule is that you are accumulating interest while the construction project is going on. They are not going to carry that or refinance it back into the loan. So, you are obligated to pay that interest over time.

President Steffey stated just to clarify, the Pennvest loans clearly states WESA. The portion of the CMA is \$77,000.00.

Mr. Minsterman stated that is for phase one. What we are talking about is phase two, the current construction. There should be two payments. The other \$19,000.00, is most likely for the interest related to the amount of funds they have spent to date, during construction, as they pay the contractor.

President Steffey stated the account type description is 2017 Pennvest loan, WESA. It may be just a clerical error.

President Steffey asked would you mind just for our new members, going over this quote?

Chief Dziezgowski stated we currently utilize the X26P taser device. They are at their end-of-life cycle, which is a 5-year cycle. We are actually in year 6. So, we moved forward with the quote for Taser 10 devices. They are the newest devices out there. We are getting the best price for our money. They are proprietary. They are the only game in town for those devices. Without those devices, we are missing a level of force prior to deadly force. So, we need that as a liability buffer for our officers. Although it is a

lot of money, and hopefully we do not have to deploy them, this was the best price that I could negotiate. Due to the fact that our other tasers are at the end-of-life cycle, this is what I will be moving forward with.

Secondly, Beedle Park. This deals with access control phase two, for Beedle Park. We already have cameras installed there. The cameras have been invaluable for damage being done to all parks. Some of the parks, we did access control, like 885 Park. We did access control for the bathrooms. We did access control for Beedle Park, for the bathrooms. But we did not at the time do access control for the concession stand, and the storage area. This would be an increase in security measures at that facility. Also, the quote is for cameras at the incoming pavilion and the kid's playground, which are long overdue. Manager Glister has been diligent with Public Works Director Mike Volpe, in contacting the electric company down there. They are having a feed put in, so we have electricity in that area to place those security cameras, and also extra lighting in that area.

President Steffey stated that since we have voted to start installing all of these cameras within our parks, it has been tremendously helpful with catching people in acts of crimes, per se.

Chief Dziezgowski stated it is a great deterrent. It helps us do our investigations. But I believe in my heart, that it also makes the community feel safe when they are out, which is paramount.

### Finance Officer/Treasurer

Mr. Haberstock stated I apologize; my finance report is not in yet. It has been a hectic year-end, start to the new year in payroll. I will just give an update, 2023 highlights. The budget for 2023 had projected a use of unreserved funds of around \$900,000.00. We ended up not needing to use any of that, I am happy to say. We still have some expenses that will incur in early 2024, that will be charged back to 2023, but, not substantially. Right now, that revenue exceeds our expenses for the year by about \$600,000.00. This was driven in large part by much better-than-expected earned income tax receipts. Over almost \$400,000.00 more than we anticipated. That is great news because that is a revenue stream that will continue in the new year. We also did much better on our interest, on our money in our savings accounts. On the expense side, the police department was over \$300,000.00 under budget. Public works and parks combined were over \$250,000.00 under budget. So, those all contributed to the good year we had.

President Steffey stated that is a good way to end the year.

#### **Public Works Director**

Mr. Volpe had nothing further to add to the written report on file in the administrative office.

### Police Chief

Chief Dziezgowski stated the end of year has been kind of quick and difficult. Our report will be in your mailboxes on Friday. I do want to speak on our annual toy drive. Through the generosity of many donors, through the collective efforts of the Police Department, and JHFR, we were able to provide gifts and toys to 12 families and 26 children in need during the holidays. We collected \$2,558.32. It is really nice just to give back. I thank everyone in the community, everyone here that donated or took time to come to Breakfast with Santa, or helped out. A special thanks to Tara Revis, who spent her own time shopping and then distributing gifts to the families in need when they came here. It is just very touching. Happy New Year, everyone.

## Mayor

Mayor McCaffrey stated Happy New Year, everyone. I would like to thank everyone who donated for the toy drive this year. That is amazing.

Welcome to our new Council Members. I look forward to working with you over the next two years.

## Acting Manager

Mr. Glister stated we talked about earlier, if we had the alternate positions filled on the Zoning Hearing Board. According to our tracking spreadsheet, we do have our two alternates filled. One is until the end of this year, and one is until the end of 2025. I just wanted to pass that along to Council.

We have been getting some complaints lately about pet waste not being picked up properly at our parks. This is just a little friendly reminder. At all of our parks, and even our municipal building here, it is a great place to take your dog, but make sure you do not leave anything behind, and take everything with you.

Chief Dziezgowski added we have cameras.

Solicitor McPeak Cromer stated I would like to request a brief executive session to discuss litigation matters immediately following the cake. We will not return and/or take any additional action after that executive session.

#### 33. General Business

President Steffey stated for the new council members, I am sure you have watched on our meetings before, but general business is just your own time to say a few words, if you have anything to express. You do not have to. I do not have any rhyme or reason as to how I go in order sometimes. So, we will start with Councilman Montgomery.

Mr. Montgomery stated I have some sad news that I have to tell everybody. Jan Cmar, our former mayor is gravely ill. I would request people pray for her in her battle to live. Thank you.

Mr. Bentz stated I am happy to be here. It was a long hard road. My fellow new council members and I came along, and accomplished a lot of things. I would like to thank my family, and a special shout out to Lisa Buckiso. She was with us the whole way. I wish everyone a happy new year.

Mr. Polick stated we have many thanks to the citizens of this Borough for supporting us in the election. Thank you to Lisa Buckiso and to any other folks out there that supported us and guided us, as well as current members here too, who gave us a way to being here today. I greatly appreciate the support from my family. As all the other families know, we were on many weekends, knocking on doors and doing everything to have the right to come here and work for this Borough. As I tell many folks on here, I had three bosses before November 6th. On November 7th, I ended up with 13,003 bosses. We are ready to work for you guys, and take the Borough into the future. Again, thank you very much.

Mr. Lynch stated it is definitely an honor to be part of this new Council group. I would definitely like to thank the residents of Jefferson Hills for entrusting me for another 4 years. Boy, time really flies. Moving on, I know Mr. Haberstock gave us some pretty good news regarding our budget. Referring back to reopening our budget, I still look at it as a critical juncture where I think it has been imperative to invest in community growth. I do not know if anyone recalled my arguments this past spring. I still feel like we continue to fall into that defensive mindset. Even though it has brought stability, I still think it has impeded

our progress. Especially when we are experiencing the demands of a promising, and a younger population. A demographic which we have not done well in our part to include. I understand that business must go on. I get that. We also need to let this be a lesson. A quick lesson that we need to learn that we need to take a more proactive stance on strategic and target investments. Our recurring defensive measure alone, if we continue down that path, will risk hindering our ability to address evolving needs and capitalizing on opportunities for any type of sustainable development. I know this term I will be getting more aggressive in pursuing these avenues. I am confident that our new Council, our Borough staff, our Boards and Commissions, including which I think we discussed, a tentative revival of our Economic Development Commission, and our residents will join together, as it is crucial to navigating these challenges and ensuring Jefferson Hills remains adaptable, resilient, and responsive to the changing dynamics of this community.

On a much brighter note, I know Christmas is usually everyone's favorite time of the year, at least for most of us. As for me, my favorite time of the year is the Geo Mack Veterans Foundation Annual Care Bag fundraiser, which is happening now, going on until January 29th. I cannot say enough about the organization. We have always been a community that has been proud of our veterans. So, let's get out there again and let's stand up for them and show them what the community is made of. I hope everyone had a very happy new year, and thank you.

Mrs. Mares stated I want to thank you for the opportunity to be up here. This is something that is very exciting. I also understand that this is a huge responsibility, and that is not something that either of us take lightly. I know that the decisions that are made here not only affect everyone in this community, but they also affect my family. I will strive to educate myself to the best of my ability on all decisions that I have to make. I have the utmost respect for everybody up here with me. I have full confidence that we will continue to work together well as a team, just like we did through our whole campaigning process. We plan to do that for our community who entrusted us to do so.

Vice President Budd stated I want to congratulate our new Council Members that are coming in. You have a giant responsibility, and quite the adventure ahead of you. You are going to have ups and downs. You are going to have a lot of good days.
